I. CALL TO ORDER

Meeting called to order at 7:00 EST by Karen Seeling, President APHA

II. ROLL CALL OF OFFICERS

Present – Karen Seeling (Pres), Tom Drost (VP), Ken Swider (Secretary), Gail Bratkowski (Treasurer), Larry Terryn (Enforcement), Cathy Gavan (Assistant to Treasurer)

- III. Open discussion on Street Lights
- a) Reviewed the cost of the streetlights. There is no charge upfront to each household. The estimated cost for the first year is \$145.00 per household.
- b) The cost for the lights could change from year to year over the 10-year period. It's estimated that the cost would not exceed \$200/yr per household.
- c) DTE would install the streetlights which includes restoration of the landscaping where they dig.
- d) LED lights are an option but they would cost slightly more. Agreed that we would stay with the sodium lights to match Forest Park.
- e) Requested DTE to send us data on for a light spillage report.
- Requested from DTE to send us an inflation report for an established lighting project for a recent
 5 year period
- g) Reviewed the voting procedure. For the street lights, we will need a minimum of 66 homes to participate in the election. If the minimum is achieved, then a simple majority will win the vote.
- h) The board will attempt to notify each household that we received their vote. If your vote is emailed in, you will receive an email response. If you mail your vote in, it will be your responsibility to reach out to a board member if you want to verify that we have received your vote.
- i) We will attempt to get the ballots mailed out by the middle to third week in October and homeowner's will have 30 days to vote.
